GRANDE PROMENADE, JUNE 28, 2009 Howard Johnson Plaza Hotel, Kansas City, Missouri

Grand Chef de Gare, Robert W. Phillips, opened the Grande Promenade at 9:00 AM with a salute to the Flag, the Pledge of Allegiance, and a much needed prayer by Grand Aumonier, Marvin Harper. The Grand Garde de la Porte George Ridley closed the door so hard that the phone fell off of the wall.

Roll call of officers showed a few more excused, a few more absent, and the rest were the same good old Voyageurs. Many paid their fines for acting up. Roll call of Grand Chefs de Gare Passe, showed there were 8 present. Roll call of Voitures showed there was a quorum present. Absent were Voitures 130, 293, 333, 447, 460, 520, 848, 966, and 1395. Grant Willis, sat in or is that stood in, for Grand Avocat, Richard Heigert, and offered a notion to follow the Rules of Procedure, seconded by George Ridley ... passed.

Notion offered by Virgil Morice, second by Don Fligge, that the minutes of the June 29, 2008 Grande Promenade be accepted as printed and sent out...passed.

Grand Chef Phillips called on the Grande Promenade Committees starting with the Audit Committee chaired by Raymond Brodzinski with the help of Sam Guenther and Robert Eisenbath. Also present were Grand Commissaire Intendant, Larry Ebersold, visitor David Christian, and Grand Correspondant Terry Lanning. Ray stated that the Audit took place on June 27, 2009 on the 11th floor of the Howard Johnson Plaza Hotel at 9:00 AM. The Committee viewed and examined all manners of money entries and funds distributed for the year. They were found to be correct and acceptable after a minor register book update. They also reviewed the Money Market account reflecting a balance of \$2,202.15, plus 4 CD's. One CD will mature on August 18, 2009, another on September 20, 2009, and another on September 23, 2009. Audit Committee recommends that these CD's be renewed at the best rate possible, but only for a short period of time. The committee feels that rates will rise in the next 12 months and we'll be in a better position to renew them at a much better rate of return. The committee also believes that we should "ladder" the certificates in the future so that every year a certificate will mature giving us the option to redeem it, if cash or funds are needed. Ray commended everyone involved in the audit and Grand Commissaire Intendant, Larry Ebersold, for the fine job he did and also the Grand Correspondant. Notion offered by Brodzinski, second by Virgil Morice, to approve the Audit Committee Report as presented and to accept yesterdays finance report...passed.

Grand Chef Phillips called on the Resolutions Committee chaired by Grant Willis. Grant reported that he opened the committee at 9:00am; there were seven other representatives that attended the meeting. Grant stated he had resolutions for Gary L. Reno for Grand Chef de Gare, Larry R. Ebersold for Grand Chef de Train, David Christian for Grand Commissaire Intendant, and Terry L. Lanning for Grand Correspondant. The committee approved these resolutions. There were no other resolutions. It is the recommendation of the committee that the four resolutions be read by the Correspondant during the election of officer's and voted on by the floor for a favorable vote. The committee adjourned at 9:01am. Grant offered a notion for the Resolutions Committees report to be accepted, seconded by Virgil Morice...passed.

Grand Chef Phillips called on the Chairman of the Credential Committee, Gary Reno. Gary reported that there was one other in attendance at the meeting. Gary gave the voting strength for each Voitures and the overall for the Grand Voiture (67) and offered a notion, second by Virgil Morice, that the report be accepted as given...passed

There was nothing submitted to the Constitution Committee, so Chairman Don Fligge had no report. Don offered a notion for his no report to be accepted, seconded by Virgil Morice ... passed.

Distinguished Voyageur Award Committee, Ray Brodzinski, stated an award was given at the banquet to Leon Hill.

Under New Business Grand Correspondant Lanning asked that all Directeurs send him a copy of their final report and for all Directeurs to make sure they clean up their pins and cards and turn in the money.

Grand Chef Phillips called on the Chairman of the Nominating Committee, Chubs Buckley. Chubs reported that the meeting was held in Room 1102 of the Howard Johnson Plaza Hotel and started at 10:00 AM. There were six other representatives that attended the meeting. The Nominating Committee

recommends to the Grande the elected officers. Meeting adjourned at 10:15 AM. Chubs read the recommendation of the Committee for elective officers for 2009-2010.

The Grande Executive Committee voted between July 1 to July 3, 2009 to approve the following actions.

- 1. The Grande delegates to the Promenade Nationale in Rochester, New York will be Leslie G. Willis, Jr., Clarence Buckley, Gary Reno, Terry Lanning, and Tony Gallagher. Gary L. Reno will be chairman of the delegation with the right to appoint any further delegates or alternates or any other changes as are necessary. The Grande gets 5 Delegates and 5 Alternates to Promenade Nationale. These five are the only ones that are known to be going to Promenade Nationale.
- 2. A resolution was received on July 1, 2009 from Voiture 848. The resolution stated there was a vote at the 2008 Promenade Nationale to open membership to any honorable discharged Veteran of the US military and no longer requires membership in the American Legion to be a member of the 40 et 8. In a regular promenade on Jun 14, 2009 Voiture 848 voted to approve the cancellation of Osage Voiture Locale 848's charter effective July 15, 2009. Voiture 848 encourages any of the Voyageurs of Voiture 848 to transfer to another Voiture Locale of their choice. After discussion of this resolution with Voiture 848 and among members of the Grande Executive Committee. The Grande Executive Committee reluctantly accepts Voiture 848 request to cancel their charter. The Grande will retain Voiture 848's number for future use.



SALUTING the FLAG Update 04: Traditionally, members of the nation's veterans service organizations have rendered the hand-salute during the national anthem and at events involving the national flag only while wearing their organization's official head-gear. The National Defense Authorization Act of 2008 contained an amendment to allow un-uniformed service members, military retirees, and veterans to render a hand salute during the hoisting, lowering, or passing of the U.S. flag. A later amendment further authorized hand-salutes during the national anthem by veterans and out-of-uniform military personnel. This was included in the Defense Authorization Act of 2009, which President Bush signed on 14 OCT 08. All other persons present should face the flag, or if applicable, remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart. Citizens of other countries present should stand at attention. All such conduct toward the flag in a moving column should be rendered at the moment the flag passes.

Regarding the Pledge of Allegiance another section of federal code that specifically relates to actions of those reciting the Pledge was not amended. The Pledge of Allegiance to the Flag (i.e. I pledge allegiance to the Flag of the United States of America, and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all), should be rendered by standing at attention facing the flag with the right hand over the heart. When not in uniform men should remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart. Persons in uniform should remain silent, face the flag, and render the military salute. It is the belief of some that commissioned Officers of the US military, when in uniform, should not render a salute, nor say the Pledge of Allegiance, but stand at attention with their hands at their sides until the Pledge is completed. The alleged reasoning behind this is that Commissioned officers of the US military are already pledged to a higher "authority" the Constitution, in their oath of office. I could find no credible reference to support this belief. The phrase "under God" was added to the pledge by a Congressional act approved on 14 JUN 54. [Source: Various Jul 09]

HISTORY LESSON-

Out in the middle of New York Harbor stands a famous lady, the Statue of Liberty. The statue was a gift from the people of France, and the cornerstone for it was laid at what was then Bedloe's Island, in the harbor, on August 5, 1884.

Funny thing about that. The Statue, itself, as I have said, was a gift from the people of France; but the base, which was a gift from the people of the United States, cost almost as much as the Statue.

To me that is rather symbolic. Somebody else can give you liberty, but you've got to establish its base for yourself. Liberty, to be maintained, cannot be just a free ride.

We might remember the story of the base of the Statue of Liberty, just as a reminder as we look at where liberty is today.
